- For Accreditation from ALEMA the following documentation needs to accompany the application form:
 -
 - NHBRC Registration
 - Certification of amount of builds builder is allowed.
 - 3 Letters of recommendation with pictures, accompanied by contact details of previous projects. (These letters are to be certified)
 - A Letter from a Stand owner in Aloes requesting builder to be accredited to build on registered stand.

- ALEMA will not accredit builders without a client in Aloes.

- ALEMA will not accredit Home owners wishing to build their own home, unless they are a 5 build accredited Builder.

- Builders may not build more homes than their Certification accreditation permits.

- First time accredited builders will be required to submit a letter of recommendation from their first project before ALEMA will allow a second project to begin, this shall continue to be the case until four completed projects.
 - ie: When project 1 is complete and signed off, project 2 may begin.
When project 2 is complete and signed off, project 3 and 4 may begin.
